School Description

Sunset Ranch Elementary School is one of 16 schools in the Rocklin Unified School District. The school serves students in Kindergarten through sixth grade, with an enrollment of approximately 830 students.

The school is located in the heart of Whitney Ranch in a very stable and supportive community which expresses its values toward education through a high level of participation and engagement. Sunset Ranch opened in the fall of 2010. The staff strives to provide an exemplary learning environment. Academic learning is certainly the primary focus of the school, but commendably, the staff operates on the principle that a caring environment that fosters self-esteem and individual development is the best road toward achieving a well-rounded education.

The students are able to approach all facets of their learning with confidence and the assurance that this school is their home. Rules of conduct are realized internally, leading to self-empowerment and initiative. Finally, the staff welcomes the direct involvement of the community in these efforts. Sunset Ranch is the focal point and center for both elementary students and the Whitney Ranch community.

At Sunset Ranch, staff and parents together are dedicated to creating a safe and orderly learning environment in which students interact positively with others and are able to develop responsibility, confidence and self-esteem while achieving their highest academic potential.

Sunset Ranch Elementary School opened in August, 2010. It is new construction and no changes or modifications have occurred due to its state of the art construction.
